(15) Description of Equipment or Protective System:

Three phase explosion proof induction motors of the type A . M 160 are made with a flame proof enclosure for motors and terminal parts. Also the terminal part can be made at protection increased safety "e". The motors part with a surface cooling and the terminal compartment are made from cast iron. The motor is closed by means of the front and rear ball bearing shields. Both shields are made from cast iron too. Behind the front shield there is a fan fastened to the shaft (aluminium alloy for Ex d IIC, cast iron for Ex d I) and protected by a perforated cover made from steel metal plate.
